What is CIMA?

Certificate Level: BA1-BA4 (no case study)

Management Level: E2, P2, F2 → Man Case Study

Strategic Level: E3, P3, F3 → Strat Case Study

Exams

CIMA consists of two different exam formats:

Objective Tests (OTs)

- ◎ One OT per subject
- ◎ On-demand, computer-based
- ◎ Results available immediately

Case Study Exams

- ◎ One Case Study per level (OCS, MCS, SCS)
- ◎ February, May, August, November sittings
- ◎ Applies your E/P/F knowledge to real business scenarios

PER (Practical Experience Requirements). Once you have passed all of your exams, your are required to complete practical workplace experience to earn your CGMA designation.
