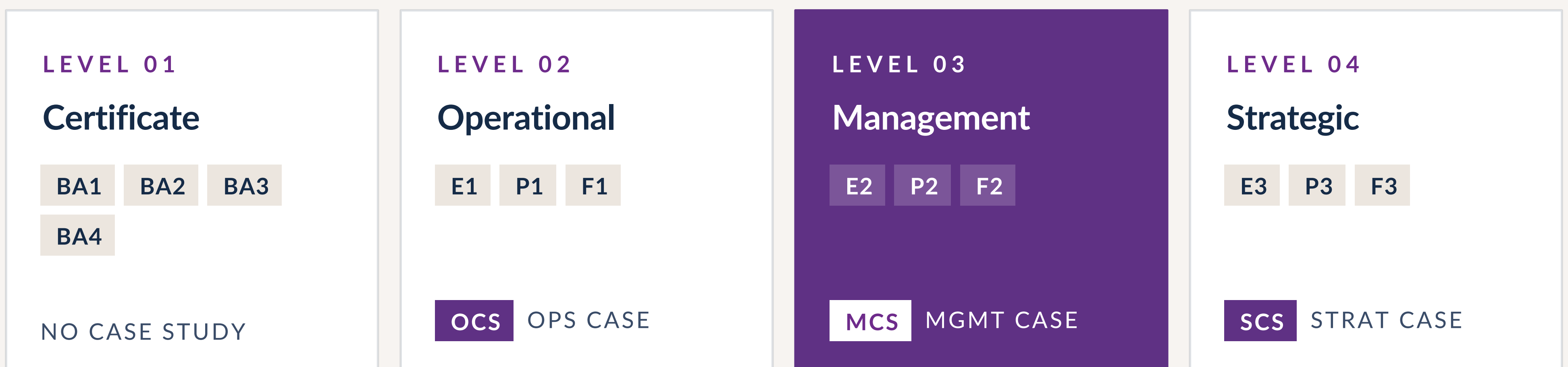

ON-DEMAND OBJECTIVE TESTS
ACROSS THE QUALIFICATION

CIMA uses two complementary exam formats. Objective Tests prove your subject knowledge. Case Studies prove you can apply it.

FORMAT 01

Objective Tests (OTs)

- One OT per subject, taken independently
- On-demand, computer-based at a test centre
- Results available immediately on screen
- Can be re-sat without waiting for a sitting window

Case Study Exams

- One Case Study Exam per level
- Applies your E, P & F knowledge to real scenarios
- Pre-seen case study released before the exam
- Four fixed sittings per year
